# 37. APOLOGIES FOR ABSENCE

Apologies had been submitted and accepted from Councillors V Watson, (on holiday), M A Cartwright, K Liddell, (work commitments), S Meikle, J Robinson, (work commitments), C Watkins, A Wilkinson. **RESOLVED the Council approve the reason submitted for absence received from the Councillors listed, and their apologies for absence be recorded.** 

# 38. To receive declarations of interest

# 39. <u>Litter</u>

#### (a)Dean Henry, Civic Pride Officer, Durham County Council

The Chair welcomed Dean Henry who had agreed to come to the Committee meeting to discuss opportunities for more and better joint working between the Town Council and existing DCC litter campaigns in the area. Mr Henry reported on Durham County Council's current activity and the support they could offer to local programmes including public engagement and education in schools etc. With the appropriate notice given, subject to resource being available he felt the County Council could combine and support the Town

Council with local initiatives on litter. There was a question and answer session and in closing the Chair thanked Mr Henry for his attendance and advice to the Committee. **RESOLVED the information given, be noted.** 

# (b) 'Show a Litter Respect'

A verbal report was to be given by Cllr Scott Meikle about a potential future litter campaign for Peterlee, unfortunately Councillor Meikle was unable to attend the meeting. **RESOLVED the item be considered at a future meeting**.

# 40. Introduction of controlled fishing - Shotton Hall Pond

Members were asked to approve the recommendation to introduce controlled fishing at Shotton Hall Pond through a syndicate arrangement and day tickets. There was considerable discussion on the proposal and it was suggested a small working party be established to consider the item further and then report back to a future meeting. This work had been well received by local residents in particular hand and had proved a very positive partnership, one which it was hoped would be developed further with future projects in Peterlee. **RESOLVED the information given, be noted.**

# 48. <u>Updates on outstanding items</u>

# (i) <u>Cricket Fencing Helford Road</u>

Members were given an update with this project where feedback was awaited from the Safety Officer and the Durham & Darlington Fire Service on the proposed fencing specification. As soon as the feedback had been received the specification would be submitted to Council for approval and then the contract would be given to the open market to price. **RESOLVED the information given, be noted and progress be awaited.** 

Councillor K & T Duffy declared an interest in the following item and took no part in the discussion which ensued.

#### (ii) Thorntree Gill Leisure Gardens

A basic specification for the appointment of an architect/design consultant along with a shortlist of suppliers had been sourced via BLOOM/NEPO as previously agreed by Council, prices would then be sought a reported back to council for consideration. **RESOLVED the information given, be noted and progress be awaited.** 

# (iii) Lowhills Road Leisure Gardens

The Town Clerk advised he had met with three gardeners from the site and had a very positive meeting, and was now awaiting a draft constitution to be submitted to the Council for endorsement. **RESOLVED the information given, be noted and progress be awaited.** 

# 49. <u>Woodhouse Park - various items including access issues, vandalism, updating of the play areas and increasing community use</u>

This item had been requested by Councillors A Long and R Moore. The Members asked about the status of the public toilets in the Park, the condition of the community building and improving the play equipment in the Park, amongst other items. The Howletch Residents Association had expressed an interest in supporting and being involved with the Park. Local Ward Members felt it was important that the Park was not only a priority for them as it was in their ward but also for it to be recognised as a Town Park and Facility. RESOLVED a report be made back to the next meeting on the refurbishment of public toilets in the park. FURTHER RESOLVED a working party be formed, with members of the Residents Association being invited to take part and they come back to Council with suggestions for improvements to the Park.

#### **Installation of LED Street Lights**

#### Street Lighting Energy Reduction Project

The new LED street lights are part of our "invest to save" Street Lighting Energy Reduction Project which involves the retrofit of existing street lights with more energy efficient LEDs.

#### Street Lighting Policy

Cabinet approved the updated Street Lighting Policy on 20 November 2013 following extensive public consultation. The majority of consultation responses were supportive of the updated policy. Please find link to the report:

LED retrofits commenced in June 2013 under the authority of the previous Street Lighting Policy which was approved by Cabinet in May 2010 following public consultation.

#### **Lighting Levels**

I can confirm that the new LED street lighting is professionally designed to comply with British Standard BS5489-1:2013 as far as reasonably practicable.

The Council has the power but not the duty to light the adopted highway under the Highways Act 1980. There are British Standards in respect of street lighting but these have no statutory basis and are advisory only. The updated Street Lighting Policy voluntarily lights residential areas to the minimum British Standard as far as reasonably practicable. The rationale for this is that we believe that the British Standard provides a good quality of lighting and that following British Standards as far as reasonably practicable provides the Council with an objective, robust and defendable standard of lighting. Adopting the minimum British Standard balances the following objectives:

- Provide an adequate and fit for purpose level of lighting where needed;
- Use the highways budget as effectively as possible recognising the pressures on all budgets and the growing highway maintenance backlog; and

Reduce carbon emissions.

In normal residential areas we have adopted P6 as the minimum British Standard. However, it should be noted that in many cases P6 cannot be technically achieved with current LEDs due to the spacings between lighting points. Therefore, to maintain our commitment to light to minimum British Standards we are lighting to the higher P5 and P4 standards in these areas. In high crime residential areas and on bus routes we have adopted P4 as the minimum British Standard. The exact same policy applies for adoptions.

The British Standard (BS5489-1:2013) lighting levels are summarised as follows for P4 to P6:

Lighting Class	Horizontal Illuminance in Lux	
S/P ratio = 1.5 and Ra>= 60	Minimum	Minimum/Average
	(Emin)	(Emin/Eav) equal to or greater than
P4	0.75	0.13
P5	0.4	0.13
P6	0.4	0.21

#### **Light Spillage**

It is important to note that street lighting is only supposed to light the road and footway and the new LED street lights achieve this objective very well due to the enhanced control provided by LED technology. The old street lights had poor control and provided what we call "light spillage" outside of the road and footway onto verges, gardens and houses, etc. Over time some people get used to the light spillage and miss it when it is eliminated by new street lights. This issue is replicated countrywide and experience tells us that most people are reassured when it is explained that the new street lights are only supposed to light the road and footway and they get used to the new street lights quickly. If residents continue to miss the light spillage on their properties then they can of course install their own security lighting on their property.

#### **LED Types**

We use a range of different LED street lights to meet the lighting levels specified above. Some of the LED street lights have more panels of LEDs than others. Generally the LEDs with more panels are used to achieve the specified lighting level where:

- There are greater spacings between lighting points;
- Turning areas where there is a greater area of highway to light; and
- Lighting to the higher P4 standard.

#### **LED Retrofits**

We have retrofitted over 40,000 LED street lights to date as part of the Street Lighting Energy Reduction Project. We estimate that over 100,000 households have been impacted by the new LED street lights and we have only received a small number of complaints mostly concerning the reduction in light spillage. We have also received a small number of compliments. This is evidence that there is widespread acceptance of the lighting levels.

In summary, the new LED street lighting is better quality and achieves significant savings in electricity consumption, carbon emissions and maintenance.

I hope that the above reassures you that the new LED street lighting is of good quality and meets and exceeds British Standards.

#### Crime

Crime can occur at any time on any part of the highway network regardless of the provision of street lighting.

The latest research commissioned by the Department of Transport confirms that there is no strong evidence to support that street lighting reduces crime although it is acknowledged that street lighting has a role to play in reducing the fear of crime. This is supported by research by the London School of Hygiene and Tropical Medicine in

partnership with University College London who has recently published their research on reduced street lighting and its impact on crime. The research found that overall there is no evidence of an association between reduced street lighting and increases in crime.

#### Dear Kevin

The Town Council considered these proposals this week and have the following comments to offer:-

- Members feel the LED lamps being used are not fit for purpose and better options should be considered that provide a larger light spread. The current street lighting falls well below illumination levels and requires further investigation;
- Most people now feel unsafe walking the streets at night because they are now so dark;
- The proposed removal of lamps is, Members feel, going to put people at risk. These footpaths are used by workers for access to and from the industrial estate, many of whom are shift workers; the routes are treacherous enough during the winter, and even more so in the dark;
- The area is used for parking by staff from the call centres. Some staff are parked there until 9pm and to de illuminate it is feared will put them at risk; recently one of the councillors daughters was attacked by hooded youths throwing projectiles. She called the Police, in fear, and was given a crime number. Several cars were attacked that night and on other nights.
- It is understood car windows have been smashed and items stolen from vehicles parked on Shotton Lane, there had also been a mugging and several break in attempts.
- To de illuminate would empower wrongdoers further as they would feel safer to commit crimes in the dark. To de illuminate they feel would create a feeling of unrest and fear for people that have no alternative but to park in that area.
- I have contacted the local Police to see if before making the final decisions I can obtain the reported crime numbers in the area. If I can get this information I shall send it on to you.
- The removal of LC8614 would reduce the conspicuousness of pedestrians walking down the centre of Shotton Lane during the hours of darkness, increasing the likelihood of accidents occurring at this location, as would the other lamps where it is proposed. There is also the issue of the safety of dog walkers in the area
- At the meeting it was asked have full risk assessments being carried out?

I sincerely hope that DCC will take these concerns and the local knowledge behind them, into account when you re consider these proposals.
