#### 1. AGREEMENTS AND TRANSACTIONS

 The Town Council entered into an agreement with HRH Princes Trust, Peterlee for use of the facilities at Hill Rigg House, Lowhills Road. This led to the completion of a successful project with Stockton Riverside College to enhance the changing facilities with sports themed murals.

### 2. THE MAYOR'S CHARITY APPEAL

The Mayor's Charity Appeal Fund in 2011/12 has raised in the order of £12,300 with over 14 organisations benefiting from the Appeal.

## 3. LISTS OF PROJECTS CARRIED OUT

Works and achievements include the following projects:-

- Closure, refurbishment and subsequent re-opening of the Eden Lane Social Club providing additional community facilities and rooms for hire. The Eden Lane Community Facility is now providing a new community exercise programme which is funded through the council's PACES project
- A reduction in the council's staffing establishment to enable the continuation of core facilities and services during difficult economic circumstances;
- Maintaining Grant Funding for the PACES Project based at the Pavilion, a community exercise programme aimed at 40

   70 year olds, and a Project Worker employed to support this programme;
- Organisation of community events such as the Sports Relief Mile;
- An increase in events and bookings for the Shotton Hall Civic Offices and Banqueting Suites;
- The provision of a variety of free training courses held at the Pavilion in partnership with East Durham Community College to help improve the careers and job prospects of local people;

The Town Clerk then asked members of the public for any questions or comments on the information given. None of the members of the public had any questions or comments for the Council.
