# 51. MDA TO MAKE A PRESENTATION ON BEHALF OF TESCO

The Chairman welcomed Mary Dryden, Managing Director of MDA, working on behalf of Tesco to the Meeting. She thanked the Town Council for the opportunity to come along to address the Meeting and gave a brief update with the proposed plans for a Tesco Extra Store to be built on the former College site, Burnhope Way, Peterlee. She reiterated that a library was in the plans to be rebuilt on this development. It was anticipated that 400 no. jobs full and part time would be created, 500 no. car parking spaces, open twenty four hours per day and security manned.

Members reiterated that the Town Council supported any improvements and competition within the Town.

Mrs Dryden reported all planning applications for retail developments would be heard on Tuesday 3<sup>rd</sup> May 2011.

A question and answers session was held and the Chairman thanked Mrs Dryden for her attendance.
