10. HORDEN & PETERLEE RUGBY FC, EDEN LANE PREMISES

Members were asked to consider a request received from Horden & Peterlee RFC to site temporary showers & changing rooms at Eden Lane. There was to be a re submission of a grant application for monies towards works to changing rooms at Eden Lane however, in the meantime temporary arrangements were needed to accommodate the Teams. Members were agreeable to this request however wished to stipulate this was a temporary arrangement only and suggested it be for the remainder of the current season, ie until the end of May 2017. Timescales for the grant application would be clarified.

RECOMMENDED the Town Council give its consent to the siting of temporary changing rooms at Eden Lane for Horden & Peterlee Rugby Football Club until the end of the current rugby season.
