

Apologies for absence were submitted on behalf of Councillors C J Robbins, M Milsom, R Jones, M A Cartwright.

262. POLICE UPDATE

The Police representatives gave an update on crime in the Town. They gave detail of high visibility patrols being carried out in the Town and reported on progress on items discussed at previous meetings. The Police confirmed that they had paid a visit to the



Peterlee Lodge regarding parking to their frontage, and it was hoped that relining of parking bays would be carried out within the renovation plans. A visit had also been made to Buckingham Bingo regarding parking and traffic congestion. Members asked that a visit be made to the Methodist Church regarding indiscriminate parking outside their premises.


Germany with the Leader and Town Clerk continuing to travel by coach.

In connection with Minute No.99(c) Request for Financial Assistance – Easington District Communicate further details on the application were given for consideration.


RESOLVED that a donation of £100.00 be granted to this organisation.

RESOLVED that the information given be noted.


FURTHER RESOLVED that the District of Easington be Asked if the Town Council could be consulted on future naming/renaming of streets in the Town.


RESOLVED that a donation of £200 be granted to Peterlee Bowling Club towards the costs involved with the Annual Open Pairs Competition.

280. LEADER'S REPORT

The Leader in his report made reference to the following matters:-

- (e) Street Lighting street lights staying on during day light hours

The Leader was very concerned at what appeared to be a lack of proper marshalling at a recent road race held on a Sunday morning in the Town, where he had witnessed a near miss accident with a cyclist and a car. He made reference to the stringent requirements implemented by the District of Easington for the appropriate licences for the Grand Parade for the Peterlee Show and asked if



similar conditions had been applied. It was agreed that the Town Clerk investigate this.

The Leader also asked if it would be possible to arrange a visit to see the recently completed extension to the Hill Rigg House and asked if the Town Clerk could arrange this for Members.

RESOLVED that the items contained within the Leader's Report be noted and action as detailed, be taken.

281. <u>REQUEST FOR FINANCIAL ASSISTANCE – PRIDE YOUTH</u> FOOTBALL TEAM

RESOLVED that a donation of £250.00 be made towards the costs of this trip.


282. <u>CONCESSIONARY USE OF THE BANQUETING SUITES – MAYOR OF PETERLEE TOWN COUNCIL</u>
