MINUTES OF THE MEETING OF THE TOWN COUNCIL HELD IN THE COUNCIL CHAMBER, SHOTTON HALL, PETERLEE ON MONDAY 15^{TH} FEBRUARY 2010

MEMBERS WERE REMINDED OF THE NEED TO DISCLOSE ANY INTEREST PREJUDICIAL OR PERSONAL IN ACCORDANCE WITH THE CODE OF CONDUCT.

PRIOR TO THE MEETING, A 15 MINUTE "OPEN SESSION" WAS HELD TO ALLOW MEMBERS OF THE PUBLIC AN OPPORTUNITY TO PUT QUESTIONS TO THE COUNCIL.

189. APOLOGIES FOR ABSENCE

Apologies for absence were submitted and approved on behalf of Councillors M Milsom, (illness) and J I Measor, (family illness).

190. POLICE – UPDATE

The Chairman welcomed PC Neil Johnson and Special Constable Chris Hepworth to the meeting. PC Johnson apologized for the non attendance of the Police at the last Council meeting, which he put down to an oversight and then gave the Council the monthly crime statistics for the Town. As part of his report PC Johnson advised that:-

- a) Peterlee Cemetery was being regularly patrolled;
- b) PC Gooden had visited Shotton Hall School and ascertained that teachers were monitoring the parking situation;
- c) That speeding on Durham Way had been referred to the Traffic Section.

The Leader of the Council gave the background of the meeting recently held at The Pavilion regarding "the Friends of the Cemetery" and asked how many officers were on duty weekend nights. The officer advised that more officers were on duty Friday and Saturday nights than at any other time.

Clarification was also sought by the Leader on stopping people parking on grass verges as the Council was receiving conflicting information on what action could be taken. These grassed areas of the Town were been churned up and something needed to be done. The Leader advised he would be taking this matter up with Chief Inspector Elaine Taylor.

The Leader also raised the following items:-

- a) The number of fixed penalty fines issued for parking on footpaths;
- b) Problems with youths in the Dene House Ward;
- c) Hotspots in the Town.

It was also noted that moves were being made regarding possible extended evening opening hours in the Youth Centre.

The Chairman thanked the officers for their attendance.

191. <u>KENMORE – CASTLE DENE SHOPPING CENTRE – PROPOSED SUPERMARKET – PRESENTAITON BY MR BEN</u> PILGRIM AND MR NICK WATSON

The Chairman welcomed Mr Pilgrim and Mr Watson to the meeting. Mr Pilgrim advised the meeting of the public consultation held the previous week, and Mr Watson gave an overview of the scheme. The scheme in the area of Argos, Sports Direct and the Job Centre would provide replacement units plus an 80,000 sq ft supermarket. Built on 2 levels the building would be concrete, glass and timber and provide a net increase of 390 car parking spaces. The project build would be 12-16 months, and hopefully would also increase the attractiveness of the Town Centre to national retailers. It was hoped the planning application could be submitted in the next few weeks, although the project was as yet in its early stages. Plans of the scheme would be forwarded to the Town Council.

A short question and answer session followed. Attention was drawn to impact on traffic into the Town Centre. Reference was also made for the need to replace the Youth Centre. It was also highlighted by Mr Watson that existing tenants would have to agree the proposals and would not be forced out.

The Chairman thanked Mr Pilgrim and Mr Watson for their attendance.

RESOLVED that progress be awaited.

The delegates' report had been circulated to Members. The Leader asked if in future, delegates could incorporate within their reports any ideas or suggestions which could be implemented locally to help the Council address climate change.

RESOLVED that the delegates' report be received.

204. <u>DURHAM COUNTY COUNCIL – CONTAMINATED LAND STRATEGY – PUBLIC CONSULTATION</u>

The Leader of the Council advised of the comments already made at the last Larger Local Councils Forum regarding the short timescale for this consultation. He also expressed the view that it would be extremely helpful if in such documents reference was made as to how areas were affected by such policy documents. The Town Clerk advised he could not see how this strategy directly impacted on Peterlee, but would seek clarification on zoning. A Local Member questioned any impact on Castle Eden Dene Burn and the burn behind Lowhills Road Leisure Gardens may have.

RESOLVED that the Town Clerk send an appropriate response to this consultation.

RESOLVED that authority be given to employ a Temporary Seasonal Worker for a eight week period over the Summer to allow satisfactory staffing levels at this time.

209. <u>LOWHILLS FORMER SPORTS CENTRE – DEVELOPMENT OF SITE – EASEMENT ACROSS TOWN COUNCIL LAND</u>

The Town Clerk had circulated to Members details of an offer made by Nomad E5 in requesting an easement to install drainage across Town Council land as part of the development of 13 bungalows on behalf of the DAMHA on the above site. This offer included tarmacing, road marking, and drainage work at the Lowhills Bowling Green Car Park, works to the perimeter of the green itself and meeting the Town Councils legal and surveyors fees.

RESOLVED that the offer from Nomad E5 be accepted, subject to the Town Clerk confirming details of the specification of the tarmacing works and a query on the level of legal fees payable.
