 Where bookings are made for the use of participants aged 16 & under a responsible adult must be present at all times during the use of the facility. The responsible adult should sign below to confirm this.
 Peterlee Town Council reserves the right to cancel/amend bookings.
A cancellation for a full refund must be made 48 hours of the date of hire. All monies will be lost if cancelled within 48 hours.
 Any damage to the facility or equipment caused by not adhering to these rules and regulations will result in the main hirer being charged for the repair, the resulting repair cost shall be charged to the main hirer as detailed on the booking form.
